CONVENTION SOMMARIZED

The NDWCA Annual Meeting/Convention was well attended with 37 counties and three cities represented.

Award winners were James D. Anderson of Richland as the Senior Career Award Winner and Joel Anderson of Grand Forks was the recipient of the Early Career Award.

We are thankful for the work done by the 2010 Planning Committee; the end result was a successful convention according to those attending. The planning committee consisted of Roger Wickstrom, Diane Almendinger, Rick Schmidt, Rachel Seifert and Becky Schroeder; thanks also to those who provided input. We couldn't do without the help of all those willing volunteers, who assisted during the convention. Thank you!

Many (42) attendees filled out the evaluation forms. I understand that's a record! We are grateful for your suggestions and opinions. Eighty-one percent gave the convention an overall rating as "Excellent"; nineteen percent rated it "Good". The majority liked the legislative panel and have asked to continue having them and another safety presentation. YELLOW TOADFLAX IS STATE'S NEWEST NOXIOUS WEED

By North Dakota Department of Agriculture BISMARCK – Agriculture Commissioner Doug Goehring has declared yellow toadflax as North Dakota's newest noxious weed.

"Yellow toadflax infestations are increasing in North Dakota," Goehring said. "The plant's ability to spread, together with the threat it poses to rangeland has made it a candidate for the noxious weed list."

Goehring also removed field bindweed and yellow starthistle from the noxious weed list.

"Yellow starthistle has virtually disappeared from North Dakota, and although field bindweed is quite common, it is really more of a nuisance than a noxious weed," Goehring said.

Goehring made the changes to the noxious weed list after consulting with North Dakota State University, members of the North Dakota Weed Control Association and the North Dakota Department of Agriculture (NDDA) weed control staff. He also conducted an online public survey and a public hearing on the new weed list.

A member of the snapdragon family, yellow toadflax (*Linaria vulgaris*) is native to southeastern Europe and southwestern Asia. Brought to this country in the 1880s as an ornamental, it was found in North Dakota as early as 1891.

Also known as butter-and-eggs, common snapdragon, toadflax, ramsted. flaxweed and Jacob's ladder, it closely resembles Dalmatian toadflax (Linaria genistifolia spp. dalmatica), also a North Dakota noxious weed. Both species are easily recognized by their bright and showy yellow flowers. Yellow toadflax has narrow lance-

shaped leaves, while Dalmatian toadflax has broad, heart-shaped leaves.

Yellow toadflax is aggressive, forming large colonies that crowd out other vegetation. It is found in a wide variety of habitats – roadsides, fields, railroad yards, rangeland, pastures, cultivated fields, meadows, forest edges and gardens.

Mature plants can produce up to 500,000 seeds annually. The roots can spread out more than 10 feet annually and give rise to daughter plants every few inches. The plant contains compounds that may be moderately toxic to livestock.

Yellow toadflax can be controlled with herbicides. Several weevils and moths are used for biological control of toadflax in parts of the U.S. and Canada. Eradication is difficult.

The state reported 1,668 acres infested with vellow toadflax in 2008.

Noxious weeds are determined by the agriculture commissioner as harmful to public health, crops, livestock, land or other property.

In addition to yellow toadflax, North Dakota's noxious weeds now include absinth wormwood, Canada thistle, musk thistle, Dalmatian toadflax, diffuse knapweed, Russian knapweed, spotted knapweed, leafy spurge, purple loosestrife and saltcedar.

"The noxious weed designation is important because noxious weeds get the greatest share of state funds for weed control through the Department of Agriculture and because failure to control noxious weeds is a class B misdemeanor," Goehring said.
