PRESIDENT"S REPORT

It is hard to think of spraying noxious weeds at 10 - 20 below zero temperatures, but this is the time to make preparations for the season. With any luck the wind will be down and we can have some long sunny days. It will warm up!

There have been changes in how we control noxious weeds in the last few years; mostly in the area of our ability to record or mark their location. By using GPS, Data loggers and mapping technology of the ag department, we are able to keep better track of present infestations and most certainly document their spread. It is also import that these records be preserved so others can have access to those locations.

There are also those new and invasive weeds we should constantly be on the lookout for; spotted knapweed and yellow toadflax to name two. I personally believe this is one of the most important parts of what a weed officer does, other than enforce the law. We must constantly be aware of what is going on in the environment we work in.

The board of directors of the association is working on the issues that were addressed at the conference from recycling and the importance of that activity to working on granting possibilities that would further the research for better control methods. And as always we are looking for ways to get the message out to the general public of the importance of noxious weed control and enforcement of the law. If you have any ideas on these issues the board would greatly appreciate your input.

Please use the tools for education that are available including the new pocket weed guide from NDSU and the ND Department of Ag; thank you for that. These do us no good sitting in a box somewhere; they need to be in the hands of the public.

I hope that you have a very productive year, keep your eyes open, but most importantly have a safe spraying season.

NAISMA Annual Meeting in FARGO, ND

The organization of the Annual Meeting of NAISMA is coming together. This will be held at the Holiday Inn in Fargo, ND. on September 29th – October 1st 2014. We will be using the NDSU Research facility and the Agriculture Experiment Station Research Greenhouse Complex in Fargo along with the excellent research faculty as our main point of interest. We have a tour lined up to see how the actual research is done once a weed is discovered all the way to it being put on an invasive list. This leads to the correct timing for the application of a chemical or for the use of a biological agent. We will have speakers on the study of population genetics of Canada thistle and Leafy Spurge and we will also be shown the gnomic genetics (DNA makeup) of Canada thistle. Another topic that will be covered is the different types of grasses that can invade natural range land and the ways to apply proper rangeland management practices to prevent this type of intrusion. We will have speakers on the different invasive insects, updates on some of the Aquatic Nuisance Species, the use of safety equipment and how to safely operate spray equipment. Along with all of this learning we will also be having a little fun at the Trade Show Mixer. Here we will be able to mingle with the vendors and sponsors of the Annual Meeting to get caught up on their latest equipment or product. We will be having a silent auction along with a fun live auction of items that have been donated. Of course we will still be having the standing committee meetings of NAISMA. Weed Free Forage: train the trainer will be offered, along with the Mapping and Professional Improvement programs. To top it off we will be having the Annual Awards Banquet. So keep watching for more updates and plan on attending the 2014 NAISMA Annual Meeting/ Conference in Fargo.

Since the conference will be in ND it would be even better that the attendance will be made up mostly of ND people.

RESEARCH GRANT PROPOSAL

If you recall from the area meetings and from the annual business meeting in January, the board has been discussing with you different scenarios with getting funding for continued research for noxious weeds. At the area meetings the idea of a stand alone trust fund was discussed. This would mean going to the legislature for such a fund. With this fund, only the interest would be used to fund the project, insuring a long term fund. At the business meeting in January, the discussion turned to possibly applying for a grant through the heritage fund, a newly established fund in North Dakota. Stan Wolf, Cass County Weed Officer, and former NDWCA president, is chairing the committee working on this project. At the writing of this newsletter, the committee is still in the process of calculating the cost of the project. Stay tuned for further updates.
