North Dakota Weed Control Association Annual Meeting

The North Dakota Weed Control Association held its 30th annual meeting on January 6th- 9th 2014 at the Best Western Seven Seas Hotel in Mandan, ND. We had a very good turnout of participants which ranged from the local weed board members, the weed officer of each county and the weed control manager for many state and federal agencies. This year we celebrated our 30th annual meeting. The education committee put together a booklet describing the many changes that have occurred over the years since the first legislative ordered the creation of the N.D. Noxious Weed Control Act. This annual meeting was held in combination with the N.D. Agriculture Commissioners Forum. This forum is required by law for the N.D. Ag. Commissioner to hold, on a yearly basis, a meeting to inform the county weed control personnel about any projects or updates required of them. At this annual meeting we had a discussion about pesticide container recycling. This has been a hot topic across the state since N.D. does not have a recycling program as in other states. It was decided that the NDWCA board of directors look into the alternatives and come up with a plan to get a recycling program going for the county weed

boards. We held an Aggregate Panel which consisted of different weed boards that came together to create a more powerful restriction on the movement of any material from a gravel pit and the creation of a permit for a gravel company to have before it can open a new pit or expand a current pit. Another topic of interest was the one on invasive grasses and how they can have an impact on the native rangeland which affects the livestock capacities and wildlife habitat. There were many other topics covered and a lot of interaction between county, state and federal agencies that are trying to solve the same problem, how to control and stop the spread of noxious and invasive weeds. The next NDWCA annual meeting will again be held at the Best Western Seven Seas in Mandan, ND on January 5-8, 2015.

2014 NAISMA Annual Conference in Fargo, ND

September 29 – October 1, 2014

The organization of the Annual Meeting of NAISMA is coming together. This will be held at the Holiday Inn in Fargo, ND on September 29th – October 1st 2014. We will be using the **NDSU Research facility** and the **Agriculture Experiment Station Research Greenhouse Complex** in Fargo along with the excellent research faculty as our main point of interest. We have a tour lined up to see how the actual research is done once a weed is discovered all the way to it being put on an invasive list. This leads to the correct timing for the application of a chemical or for the use of a biological agent.

We will have speakers on the study of population **genetics** of Canada thistle and Leafy Spurge and we will also be shown the gnomic genetics (DNA makeup) of Canada thistle. Another topic that will be covered is the different types of grasses that can invade natural range land and the ways to apply proper rangeland management practices to prevent this type of intrusion. We will have speakers on the different invasive insects, updates on some of the Aquatic Nuisance Species, the use of safety equipment and how to safely operate spray equipment.

Along with all of this learning we will also be having a little fun at the Trade Show Mixer. Here we will be able to mingle with the vendors and sponsors of the Annual Meeting to get caught up on their latest equipment or product. We will be having a silent auction along with a fun live auction of items that have been donated. Of course we will still be having the standing committee meetings of NAISMA. Weed Free Forage: train the trainer will be offered, along with the Mapping and Professional Improvement programs. To top it off we will be having the Annual Awards Banquet.
