ND Department of Agriculture Report

The Landowner Assistance Program (LAP) vouchers have a hard and fast deadline of January 15th. All requests for reimbursement must be received by the deadline for any cost-sharing between July 1, 2014 and December 31, 2014 to be processed.

Unspent funds are subject to revocation on a case by case basis. The review and reallocation process will not affect future allocations to weed boards. The primary goal of this process is to spend the funds provided for weed control from the legislature. The plan is to secure funds for the future by not returning weed control funds to the Environmental and Rangeland Protection (ERP) fund.

Remember if we don't spend it now, we may not get it later.

NAISMA Annual Meeting in FARGO, NDThe NAISMA Annual Meeting was held at the Holiday Inn in Fargo, ND. on September 29th October 1st 2014. We used the NDSU Research facility and the Agriculture Experiment Station Research Greenhouse Complex in Fargo along with the excellent research faculty as our main point of interest. We toured these facilities and were able to see how the actual research is done once a weed is discovered all the way to it being put on an invasive list. This leads to the correct timing for the application of a chemical or for the use of a biological agent.

The meetings started with an Education summit and Marketing outreach to organize a combined effort for invasive species education. A Midwest Bio-Control Focus Group was organized which will help coordinate the discovery and use of biological agent use on invasive weeds. Weed Free Forage, Professional Improvement, Manager of Invasive Plants and Mapping committees each got together to discuss the current operations of each committee and had very good discussion on the advancement of each committee.
