## **Industry Report** (Taken from the 2016 Annual Business Meeting Minutes)

Bill Walker, NDWCA board of directors industry representative and CPS Timberland gave the state of the industry report for 2016.

Bayer is still waiting for EPA on the haying and grazing label on Perspective. Bayer has Method. It is a safe product, and it is a liquid. \$311.04/gallon. Does have the haying and grazing label, for one year.

Esplanade 200SC is a bare ground chemical that they do have, as well. It is quite expensive per gallon, but when figured out per acre, it is affordable.

Dow has retained the government program for 2016. Ag dealers' prices have gone up, but not government prices. Tordon is the same way. Picloram is going back through a re-registration process this year. Baslin has not been registered as of yet. This will replace Garlon 3A. Graslan L is now out for sale. It is a premix of Tordon/Coline (a new type of 2-4D). Has less odor then regular 2-4D. \$44/gallon price.

BASF supplies should be in good supply. They have 1 rep in the entire world, and he is in an office in Virginia.

Monsanto: Glysophate should be fine. A lot of misinformation has been printed on this concerning Glysophate.

Other chemicals like 2-4D and others should be in good supply, and stable pricing.

# common tansy Tanacetum vulgare Family: Asteraceae

Other common names: garden tansy

Native to: Asia and Europe Toxic: humans, livestock

**General Description:** Common tansy is an aromatic perennial with rhizomes, reaching 1 to 5 feet tall, with fern like foliage and yellow button-like flowers.

**Flower Description:** Flower-heads are numerous, button-like and yellow. They are 1/4 to 1/2 inches across in flat-topped dense clusters. Flower-heads composed of all disk flowers and are absent of ray flowers.

**Leaf Description:** Leaves are alternate and pinnately compound (leaflets arranged on both sides of a common stalk). They are deeply divided into numerous, narrow, toothed segments. Leaves become smaller towards the top of the stalk and are strongly aromatic when crushed.

**Stem Description:** Plants have multiple stems that are brown to reddish-brown and dotted with glands.

Fruit/Seed Description: Seeds are small (1 to 2 mm), gland dotted and with ribs. Seeds have crown shaped pappus.

**Reproduction:** Common tansy reproduces by numerous tufted seeds dispersed by wind and water. It also reproduces vegetatively by forming new plants from root fragments.

Common tansy is generally found along roadsides, waste areas, streambanks and in pastures.

General Control Strategy: Remove seeds from personal gear, equipment, machinery, vehicles, and animals before leaving an infested area.

**Mechanical Control:** Mow or cut infestations before flowering and seed-set occur to eliminate seed production. Multiple treatments will be required to exhaust the plant's resources. Monitor treatment success continuously over successive years.

Cultural Control: Minimize soil disturbance and re-vegetate any disturbed areas promptly. Maintain a healthy native plant community. Monitor and identify areas where invasions of common tansy are likely to occur.

**Herbicide Control:** Perspective herbicide at 4.5 to 8oz/acre, with a MSO or non-ionic surfactant. See label for more details.

When to Apply Herbicide: Apply to active growing plants in the spring.

## Did You know?

Henry Wallace, a former Vice President under Franklin D. Roosevelt, had a large interest in chicken breeding. In agriculture he is more famous for starting a company called Pioneer Hybrid Seeds. Today Pioneer is one of the largest seed companies in the world.
